BY-LAW 1227-2018

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Main Street and Southwood Drive.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Main Street	East	Kingston Road and Lyall Avenue	Anytime
Main Street	East	Swanwick Avenue and a point 70 metres north of Swanwick Avenue	8:00 a.m. to 4:00 p.m., Mon. to Fri.

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Main Street	East	Lyall Avenue and a point 69 metres south	Anytime
Main Street	East	Kingston Road and a point 101 metres south of Lyall Avenue	Anytime

- C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Main Street	East	Swanwick Avenue and Gerrard Street East	4:00 p.m. to 6:00 p.m. Mon. to Fri., except public holidays
Main Street	West	Swanwick Avenue and Gerrard Street East	7:00 a.m. to 9:00 a.m. Mon. to Fri., except public holidays

- D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Main Street	East	Gerrard Street East and a point 53.5 metres south	4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays

- E. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Main Street	East	A point 70 metres north of Swanwick Avenue and Gerrard Street East	8:00 a.m. to 4:00 p.m. Mon. to Fri.; 8:00 a.m. to 6:00 p.m., Sat.	1 hour

F. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Main Street	West	Swanwick Avenue and Gerrard Street East	Anytime

G. By inserting in Schedule XIX (One-Way Traffic Lanes) in § 950-1318, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Lanes)	(In Column 4 Time and/or Days)	(In Column 5 Direction)
Main Street	Gerrard Street East and a point 30.5 metres south	Westerly Northbound	Anytime	Northbound left-turning
Main Street	Kingston Road and a point 30.5 metres north	Easterly Southbound	Anytime	Southbound left-turning
Southwood Drive	Kingston Road and a point 30.5 metres south	Westerly Northbound	Anytime	Northbound left-turning
