CITY OF TORONTO

BY-LAW 1253-2018

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Runnymede Road.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

G. By deleting from Schedule XIX (One-Way Traffic Lanes) in § 950-1318, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Lanes)	(From Column 4 Time and/or Days)	(From Column 5 Direction)
Runnymede Road	A point 30.5 metres north of Dundas Street West and a point 19.5 metres further north	Easterly Southbound	Anytime	Southbound left-turning
