## CITY OF TORONTO

### BY-LAW 88-2019

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Aviemore Drive, Grampian Crescent, Hathor Crescent, Riverside Drive, Rowntree Mill Road and Whitfield Avenue.**

The Etobicoke York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, of the City of Toronto is amended as follows:
  - A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Aviemore Drive	Both	Islington Avenue and Franel Crescent	12:00 a.m. to 6:00 a.m.
Grampian Crescent	Both	Aviemore Drive (south intersection) and Aviemore Drive (north intersection)	12:00 a.m. to 6:00 a.m.
Hathor Crescent	Both	Rowntree Mill Road (west intersection) and Rowntree Mill Road (east intersection)	12:00 a.m. to 6:00 a.m.
Riverside Drive	South	Apted Avenue and a point 518 metres west of Apted Avenue	12:00 a.m. to 6:00 a.m.
Rowntree Mill Road	Both	Emily Avenue and a point 50 metres east of Apted Avenue	12:00 a.m. to 6:00 a.m.
Whitfield Avenue	Both	Apted Avenue and the west end of Whitfield Avenue	12:00 a.m. to 6:00 a.m.

B. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Aviemore Drive	Both	Islington Avenue and Frael Crescent	12:00 a.m. to 6:00 a.m.
Grampian Crescent	Both	Aviemore Drive (south intersection) and Aviemore Drive (north intersection)	12:00 a.m. to 6:00 a.m.
Hathor Crescent	Both	Rowntree Mill Road (west intersection) and Rowntree Mill Road (east intersection)	12:00 a.m. to 6:00 a.m.
Rowntree Mill Road	Both	Emily Avenue and a point 50 metres east of Apted Avenue	12:00 a.m. to 6:00 a.m.
Whitfield Avenue	Both	Apted Avenue and the west end of Whitfield Avenue	12:00 a.m. to 6:00 a.m.
