

**CITY OF TORONTO**

**BY-LAW 357-2019**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Armoury Street.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Armoury Street	South	University Avenue and Chestnut Street	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Armoury Street	South	University Avenue and Centre Avenue	Anytime

C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Armoury Street	Both	Centre Avenue and Chestnut Street	Anytime

- D. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Armoury Street	South	A point 36 metres east of University Avenue and Chestnut Street	Anytime

- E. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Armoury Street	South	A point 36 metres east of University Avenue and Centre Avenue	Anytime

- F. By inserting in Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(In Column 1 Intersection)	(In Column 2 Stop Street or Highway)
Armoury Street and Centre Avenue	Armoury Street

- G. By deleting from Schedule XXXVIII (Pedestrian Crossovers) in § 950-1337, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Location)
Armoury Street	Immediately east of Centre Avenue

2. This By-law shall be effective February 21, 2019.
