

CITY OF TORONTO

BY-LAW 439-2019

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Appleton Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Appleton Avenue	East	A point 55 metres north of St. Clair Avenue West and Glenhurst Avenue	From the 16th day of each month to the last day of each month, Apr. 1 to Nov. 30, inclusive
Appleton Avenue	East	A point 55 metres north of St. Clair Avenue West and Glenhurst Avenue	Anytime, Dec. 1 to Mar. 31, inclusive
Appleton Avenue	East	St. Clair Avenue West and a point 55 metres north	16th day to the last day of each month, from Apr. 1 to Nov. 30, inclusive
Appleton Avenue	East	St. Clair Avenue West and a point 55 metres north	Anytime, from 7:00 p.m. on the 1st day of Dec. of one year to 7:00 p.m. on the 1st day of Apr. the next following year, inclusive
Appleton Avenue	West	A point 55 metres north of St. Clair Avenue West and Glenhurst Avenue	From the first day to the 15th day of each month, from Apr. 1 to Nov. 30, inclusive
Appleton Avenue	West	St. Clair Avenue West and a point 55 metres north	First day to the 15th day of each month, from Apr. 1 to Nov. 30, inclusive
