BY-LAW 664-2019

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Colborne Street and Leader Lane.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule VI (Commercial Loading Zones) in § 950-1305, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Time and/or Days)
Leader Lane	West	Between a point 30.5 metres south of King Street East and Colborne Street	Anytime

B. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Colborne Street	North	A point 71 metres east of Victoria Street and a point 49.2 metres west of Church Street	Anytime

C. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Colborne Street	North	A point 71 metres east of Victoria Street and Leader Lane	Anytime

D. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Colborne Street	North	Church Street and a point 49.2 metres west	Anytime
Colborne Street	South	Church Street and Colborne Lane	Anytime

E. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Colborne Street	Both	Leader Lane and Church Street	Anytime

F. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Colborne Street	South	Leader Lane and Colborne Lane	Anytime	1 hour

G. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Leader Lane	West	King Street East and a point approximately 30.5 metres south	Anytime

H. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Leader Lane	West	Colborne Street and King Street East	Anytime
