BY-LAW 861-2019

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Gladstone Avenue, Havelock Street and Rusholme Park Crescent.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Gladstone Avenue	West	College Street and lane first south of College Street	8:00 a.m. to 6:00 p.m.
Havelock Street	East	College Street and Sylvan Avenue	From the 1 st day to the 1 th day of each month, Apr. 1 to Nov. 30, inclusive
Rusholme Park Crescent	East	College Street and a point 39 metres south	Each Thu., Apr. 1 to Nov. 30, inclusive
Rusholme Park Crescent	West	College Street and the south end of Rusholme Park Crescent	Anytime, except each Thu., Apr. 1 to Nov. 30, inclusive

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Gladstone Avenue	Both	College Street and a point 15 metres south	Anytime
Havelock Street	West	College Street and a point 15 metres north	Anytime
Rusholme Park Crescent	East	A point 15 metres south of College Street and a point 24 metres further south	Each Thurs., Apr. 1 to Nov. 30, inclusive
Rusholme Park Crescent	East	College Street and a point 15 metres south	Anytime
Rusholme Park Crescent	West	The south end of Rusholme Park Crescent and a point 35 metres south of College Street	Anytime, except each Thu., Apr. 1 to Nov. 30, inclusive
Rusholme Park Crescent	West	College Street and a point 35 metres south	Anytime

C. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Gladstone Avenue	West	College Street and a point 94.2 metres south	8:00 a.m. to 6:00 p.m.	1 hour

D. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Gladstone Avenue	West	A point 15 metres south of College Street and a point 79.2 metres further south	8:00 a.m. to 6:00 p.m.	1 hour
