

**CITY OF TORONTO**

**BY-LAW 1002-2019**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting  
Credit Union Drive, Eccleston Drive, Mobile Drive and Swift Drive.**

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Eccleston Drive	North	The west end of Eccleston Drive and Swift Drive	Anytime
Mobile Drive	South	The west end of Mobile Drive and Credit Union Drive	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Credit Union Drive	West	Mobile Drive and Eglinton Avenue East	Anytime
Eccleston Drive	North	Sloane Avenue and the west end of Eccleston Drive	Anytime
Eccleston Drive	South	Sloane Avenue and Swift Drive	1:00 a.m. to 6:00 a.m.
Mobile Drive	North	Bermondsey Road and a point 128.5 metres west of Bermondsey Road	Anytime
Mobile Drive	North	Credit Union Drive and a point 190 metres east	1:00 a.m. to 6:00 a.m.

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Credit Union Drive	Both	Mobile Drive and Eglinton Avenue East	Anytime
Ecclestone Drive	Both	Swift Drive and Sloane Avenue	Anytime
Mobile Drive	Both	Credit Union Drive and Bermondsey Road	Anytime
Swift Drive	Both	Eglinton Avenue East and Ecclestone Drive	Anytime

2. This By-law shall be effective commencing August 31, 2019.
