

CITY OF TORONTO

BY-LAW 1039-2019

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Edwin Avenue, Macaulay Avenue, Ruskin Avenue, Sousa Mendes Street and Wallace Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Sousa Mendes Street	East	Wallace Avenue and Ruskin Avenue	Anytime

B. By deleting from Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(From Column 1 Intersection)	(From Column 2 Stop Street or Highway)
Edwin Avenue and Ruskin Avenue	Edwin Avenue
Ruskin Avenue and Edwin Avenue	Ruskin Avenue

C. By inserting in Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(In Column 1 Intersection)	(In Column 2 Stop Street or Highway)
Edwin Avenue and Ruskin Avenue/Sousa Mendes Street	Edwin Avenue
Macaulay Avenue and Sousa Mendes Street	Macaulay Avenue (westbound)
Ruskin Avenue and Edwin Avenue/Sousa Mendes Street	Ruskin Avenue

(In Column 1 Intersection)	(In Column 2 Stop Street or Highway)
Sousa Mendes Street and Edwin Avenue/Ruskin Avenue	Sousa Mendes Street
Sousa Mendes Street and Wallace Avenue	Sousa Mendes Street
Wallace Avenue and Sousa Mendes Street	Wallace Avenue

- D. By inserting in Schedule XXX (Heavy Vehicles Prohibited) in § 950-1329, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Prohibited Times and/or Days)
Sousa Mendes Street	Wallace Avenue and Ruskin Avenue	Anytime

- E. By inserting in Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Speed Limit (km/h))
Sousa Mendes Street	Wallace Avenue and Ruskin Avenue	30
