BY-LAW 1069-2019

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Brunel Court.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Brunel Court	East	A point 9 metres south of Fort York Boulevard and a point 11 metres further south	Anytime (car-share vehicles excepted)
Brunel Court	West	Fort York Boulevard and the south end of Brunel Court	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Brunel Court	East	A point 33 metres south of Fort York Boulevard and a point 11 metres further south	Anytime (car-share vehicles excepted)

C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Brunel Court	Both	Fort York Boulevard and a point 33 metres further south	Anytime
Brunel Court	Curb sides of cul-de-sac	A point 100 metres south of Fort York Boulevard and the south end of Brunel Court, from the west side to the east side of the north-south leg of Brunel Court	Anytime
Brunel Court	East	A point 44 metres south of Fort York Boulevard and a point 56 metres further south	7:00 a.m. to 4:00 p.m., Mon. to Fri.
Brunel Court	West	A point 64 metres south of Fort York Boulevard and a point 9 metres further south	Anytime

D. By inserting in Schedule XXXVII (School Bus Loading Zones) in § 950-1336, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times and/or Days)
Brunel Court	West	Between a point 33 metres south of Fort York Boulevard and a point 31 metres further south	7:00 a.m. to 4:00 p.m., Mon. to Fri.
Brunel Court	West	Between a point 73 metres south of Fort York Boulevard and a point 27 metres further south	7:00 a.m. to 4:00 p.m., Mon. to Fri.

E. By deleting from Schedule XLIII (Car-Share Vehicle Parking Areas) in § 950-1342, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Number of Spaces)	(From Column 5 Car-Share Organization/ Company)
Brunel Court	East	A point 9 metres south of Fort York Boulevard and a point 11 metres further south	2	Zipcar

- F. By inserting in Schedule XLIII (Car-Share Vehicle Parking Areas) in § 950-1342, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Number of Spaces)	(In Column 5 Car-Share Organization/ Company)
Brunel Court	East	A point 33 metres south of Fort York Boulevard and a point 11 metres further south	2	Zipcar
