BY-LAW 1430-2019

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Caroline Carpenter Grove, Downsview Park Boulevard, Frederick Tisdale Drive, John Perkins Bull Drive, Locust Lodge Gardens, Sarah Jackson Crescent, Stanley Greene Boulevard, Thomas Mulholland Drive and William Duncan Road.

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
