**CITY OF TORONTO**

**BY-LAW 1603-2019**

**To repeal By-law 1467-2019 and amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting the renaming of Coxwell Avenue, between Queen Street East and Lake Shore Boulevard East, as "Lower Coxwell Avenue".**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Coxwell Avenue	Both	Eastern Avenue and Queen Street East	4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays
Coxwell Avenue	Both	Lake Shore Boulevard East and Eastern Avenue	7:00 a.m. to 9:00 a.m., 4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays
Coxwell Avenue	Both	Queen Street East and Eastern Avenue	7:00 a.m. to 9:00 a.m., Mon. to Fri., except public holidays

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Lower Coxwell Avenue	Both	Lake Shore Boulevard East and Queen Street East	7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

E. By deleting from Schedule XVIIA (Parking and Standing during Major Snow Storm Conditions) in § 950-1316A, the following in alphabetical order by street name:

Coxwell Avenue	Eastern Avenue and a point 34.7 metres north of Milverton Boulevard

F. By inserting in Schedule XVIIA (Parking/Standing on or Blocking Streetcar Tracks during Major Snow Storm Conditions) in § 950-1316A, the following in alphabetical order by street name:

Coxwell Avenue	Lake Shore Boulevard East and Eastern Avenue
Coxwell Avenue	The north side of Eastern Avenue and a point 40.6 metres north of Milverton Boulevard

J. By inserting in Schedule XXVI (Through Highways) in § 950-1325, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)
Coxwell Avenue	The north side of Queen Street East and a point 40.6 metres north of Milverton Boulevard
Lower Coxwell Avenue	The north side of Lake Shore Boulevard East and the south side of Queen Street East

K. By deleting from Schedule XXXIX (Traffic Control Signals) in § 950-1338, the following in alphabetical order by street name:

Eastern Avenue and a point 175 metres east of Coxwell Avenue/Private Access

Eastern Avenue and Coxwell Avenue

Lake Shore Boulevard East and Coxwell Avenue/Ashbridges Bay Park Road

Queen Street East and Coxwell Avenue

L. By inserting in Schedule XXXIX (Traffic Control Signals) in § 950-1338, the following in alphabetical order by street name:

Eastern Avenue and a point 175 metres east of Lower Coxwell Avenue/Private Access

Eastern Avenue and Lower Coxwell Avenue

Lake Shore Boulevard East and Lower Coxwell Avenue/Ashbridges Bay Park Road

Queen Street East and Coxwell Avenue/Lower Coxwell Avenue

2. By-law 1467-2019 is repealed.
