BY-LAW 7-2020

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Hillsdale Avenue East and Soudan Avenue.

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Hillsdale Avenue East	North	A point 12 metres east of Cleveland Street and a point 41 metres west of Bayview Avenue	Anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive and from the 16 th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Hillsdale Avenue East	North	Bayview Avenue and a point 41 metres west	Anytime
Hillsdale Avenue East	South	Bayview Avenue and a point 54.9 metres west	Anytime
Soudan Avenue	North	Bayview Avenue and a point 45 metres west	Anytime
Soudan Avenue	South	Mount Pleasant Road and Bayview Avenue	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Hillsdale Avenue East	North	A point 12 metres east of Cleveland Street and a point 50 metres west of Bayview Avenue	Anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive and from the 16 th day to the last day of each month from Apr. 1 to Nov. 30, inclusive

Hillsdale Avenue East	Both	Bayview Avenue and a point 50 metres west	Anytime
Soudan Avenue	Both	Bayview Avenue and a point 45 metres west	Anytime

D. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Hillsdale Avenue East	North	A point 12 metres east of Cleveland Street and a point 41 metres west of Bayview Avenue	10:00 a.m. to 6:00 p.m., Mon. to Fri., 1 st day to the 15 th day of each month from Apr. 1 to Nov. 30, inclusive	1 hour

E. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

Hillsdale Avenue East	North	A point 12 metres east of Cleveland Street and a point 50 metres west of Bayview Avenue	10:00 a.m. to 6:00 p.m., Mon. to Fri. from the 1 st day to the 15 th day of each month from Apr. 1 to Nov. 30, inclusive	1 hour
