CITY OF TORONTO

BY-LAW 177-2020

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, to correct a technical error with respect to the reduction of the speed limit from 50 km/h to 30 km/h on Eastmount Avenue (former Ward 29, now Ward 14).

Whereas Toronto and East York Community Council, at its meeting held on October 6, 2015, adopted as amended, Item TE11.72 entitled "Reduce Speed Limit to 30 km/h on all Local Roads in Toronto and East York District" and, in so doing, directed that the speed limit on local roads with 50 km/h speed limits in the Toronto and East York Community Council area, excluding those roads that bound more than one Community Council area, with some other exceptions, be reduced to 30 km/h; and

Whereas Toronto and East York Community Council, on January 16, 2018, enacted By-law 69-2018 to reduce the speed limit from 50 km/h to 30 km/h on local roads in the then Ward 29; and

Whereas By-law 69-2018 reduced the speed limit from 50 km/h to 30 km/h on Eastmount Avenue, between Cambridge Avenue and the east end of Eastmount Avenue; and

Whereas Eastmount Avenue begins west of Cambridge Avenue, not east of Cambridge Avenue, and terminates at Cambridge Avenue, the above-mentioned 30 km/h speed limit regulation should have been enacted for Eastmount Avenue, between Cambridge Avenue and the west end of Eastmount Avenue; and

Whereas under Section 169-5.2B of Chapter 169, Officials, City, of The City of Toronto Municipal Code, the City Solicitor, in consultation with the City Clerk, may submit bills directly to make technical amendments to The City of Toronto Municipal Code and other by-laws to correct technical errors;

The Toronto and East York Community Council enacts:

- 1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
- A. By deleting from Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:
