

CITY OF TORONTO

BY-LAW 196-2020

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Cumberland Street and Yorkville Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
- A. By deleting from Schedule VI (Commercial Loading Zones) in § 950-1305, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Times and/or Days)
Cumberland Street	South	Between a point 61 metres east of Bay Street and a point 100 metres west of Yonge Street	6:00 a.m. to 4:00 p.m., Mon. to Fri.

- B. By inserting in Schedule VI (Commercial Loading Zones) in § 950-1305, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
Cumberland Street	South	Between a point 61 metres west of Yonge Street and a point 34 metres further west	6:00 a.m. to 4:00 p.m., Mon. to Fri.

- C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Cumberland Street	North	Yonge Street and a point 61 metres east of Bay Street	Anytime

D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Cumberland Street	North	Bay Street and Yonge Street	Anytime
Cumberland Street	South	Bay Street and a point 95 metres west of Yonge Street	Anytime
Cumberland Street	South	Yonge Street and a point 61 metres west	Anytime
Yorkville Avenue	North	A point 48 metres east of Bay Street and a point 71.5 metres further east	Anytime
First east-west public lane east of Bay Street	Both	Cumberland Street and the first east-west public lane north of Cumberland Street	Anytime

E. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Cumberland Street	Both	Bay Street and a point 61 metres east	Anytime
Yorkville Avenue	North	A point 48 metres east of Bay Street and Yonge Street	Anytime

F. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Yorkville Avenue	North	A point 119.5 metres east of Bay Street and Yonge Street	Anytime

G. By deleting from Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Times and/or Days)	(From Column 4 Direction)
Cumberland Street	A point 61 metres east of Bay Street and Yonge Street	Anytime	Eastbound

H. By inserting in Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Times and/or Days)	(In Column 4 Direction)
Cumberland Street	Bay Street and Yonge Street	Anytime	Eastbound

2. This By-law shall be effective commencing March 1, 2020.
