BY-LAW 292-2020

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Phipps Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule VI (Commercial Loading Zones) in § 950-1305, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Times and/or Days)
Phipps Street	South	Between a point 68.4 metres east of Bay Street and a point 35 metres west of St. Nicholas Street	Anytime

B. By inserting in Schedule VI (Commercial Loading Zones) in § 950-1305, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
Phipps Street	South	Between Bay Street and a point 35 metres west of St. Nicholas Street	Anytime

C. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Phipps Street	South	A point 68.4 metres east of Bay Street and a point 35 metres west of St. Nicholas Street	Anytime

D. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Phipps Street	South	Bay Street and a point 35 metres west of St. Nicholas Street	Anytime

E. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Phipps Street	South	Bay Street and a point 68.4 metres east	Anytime

F. By deleting from Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Times and/or Days)	(From Column 4 Direction)
Phipps Street	Bay Street and a point 68.4 metres east	Anytime	Westbound
