

**CITY OF TORONTO**

**BY-LAW 294-2020**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Widmer Street.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule V (Stands for Taxicabs) in § 950-1304, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 3 Number of Taxicabs)	(From Column 3 Times and/or Days)
Widmer Street	East	Between a point 15 metres south of Adelaide Street West and a point 24 metres further south	4	Anytime

B. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Widmer Street	East	A point 43 metres north of King Street West and Adelaide Street West	Anytime

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Widmer Street	West	Adelaide Street West and Richmond Street West	Anytime

D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Widmer Street	East	Adelaide Street West and a point 80 metres south	Anytime
Widmer Street	West	A point 90 metres south of Adelaide Street West and Richmond Street West	Anytime

E. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Widmer Street	West	King Street West and Adelaide Street West	8:00 a.m. to 6:00 p.m.	1 hour

F. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Widmer Street	West	King Street West and a point 90 metres south of Adelaide Street West	8:00 a.m. to 6:00 p.m.	1 hour

G. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Widmer Street	East	A point 15 metres south of Adelaide Street West and a point 24 metres further south	Anytime

Widmer Street	East	King Street West and the first east-west public laneway north	Anytime
