BY-LAW 307-2020

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Emerson Avenue, Paton Road, St. Clarens Avenue, Wallace Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Wallace Avenue	North	Symington Avenue and Dufferin Street	Anytime
Wallace Avenue	South	St. Clarens Avenue (east intersection) and Lansdowne Avenue	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:
