

**CITY OF TORONTO**

**BY-LAW 400-2020**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Argyle Street.**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Argyle Street	North	A point 15 metres west of Dovercourt Road and a point 17 metres further west	8:00 a.m. to 6:00 p.m.
Argyle Street	North	Dovercourt Road and a point 42.7 metres east	Anytime
Argyle Street	North	Dovercourt Road and a point 48.8 metres west	8:00 a.m. to 6:00 p.m., Mon. to Fri.
Argyle Street	North	Dovercourt Road and Lisgar Street	16 <sup>th</sup> day to the last day of each month, inclusive, from Apr. 1 to Nov. 30, inclusive

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Argyle Street	North	Lisgar Street and a point 32 metres west of Dovercourt Road	From Dec. 1 of one year to Mar. 31 of the next following year, inclusive, and from the 16 <sup>th</sup> day to the last day of each month from Apr. 1 to Nov. 30, inclusive

Argyle Street	South	A point 20 metres east of Ossington Avenue and Givins Street	Anytime

Argyle Street	Ossington Avenue and a point 20 metres east	Northerly Westbound	Anytime	Westbound
Argyle Street	Ossington Avenue and a point 20 metres east	South curb lane	Anytime	Eastbound (bicycles only)

H. By deleting from Schedule XXIII (Prohibited Turns) in § 950-1322, the following in alphabetical order by street name:

(From Column 1 Intersection or Portion of Highway)	(From Column 2 Direction)	(From Column 3 Turns Prohibited)	(From Column 4 Times and/or Days)
Argyle Street and Argyle Place	Westbound	Left	Anytime (bicycles excepted)
Argyle Street and Givins Street	Westbound	Right	Anytime (bicycles excepted)

I. By inserting in Schedule XXIII (Prohibited Turns) in § 950-1322, the following in alphabetical order by street name:

(In Column 1 Intersection or Portion of Highway)	(In Column 2 Direction)	(In Column 3 Turns Prohibited)	(In Column 4 Times and/or Days)
Argyle Street and Argyle Place	Northbound	Right	Anytime (bicycles excepted)

J. By deleting from Schedule XXV (Entry Prohibited) in § 950-1324, the following in alphabetical order by street name:

(From Column 1 Highway Not To Be Entered)	(From Column 2 From)	(From Column 3 Prohibited Times and/or Days)
Argyle Street, west of Givins Street	Argyle Street, east of Givins Street	Anytime (bicycles excepted)

K. By deleting from Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(From Column 1 Intersection)	(From Column 2 Stop Street or Highway)
Argyle Street and Beaconsfield Avenue	Argyle Street (westbound bicycle traffic)
Argyle Street and Davenport Road	Argyle Street (westbound bicycle traffic)

L. By inserting in Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:
