BY-LAW 597-2020

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting speed limit reductions on Carlaw Avenue, Cosburn Avenue, Greenwood Avenue, Logan Avenue, Pretoria Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By deleting from Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Speed Limit (km/h))
Carlaw Avenue	Danforth Avenue and Mortimer Avenue	30
Carlaw Avenue	Gerrard Street East and Riverdale Avenue	40
Carlaw Avenue	Riverdale Avenue and Danforth Avenue	40
Carlaw Avenue	Queen Street East and Eastern Avenue	40
Greenwood Avenue	Danforth Avenue and a point 40 metres north of Milverton Boulevard	40
Logan Avenue	Bain Avenue and Danforth Avenue	40
Logan Avenue	Commissioners Street and Eastern Avenue	30
Logan Avenue	Eastern Avenue and a point 200 metres south	30
Logan Avenue	Eastern Avenue and Gerrard Street East	40
Logan Avenue	Gerrard Street East and Bain Avenue	30
Pretoria Avenue	Broadview Avenue and Ellerbeck Street	40
Pretoria Avenue	Cambridge Avenue and Broadview Avenue	40

B. By inserting in Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:
