## CITY OF TORONTO

### BY-LAW 639-2020

#### To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Portland Street, Richmond Street West.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Portland Street (TO)	West	Adelaide Street West and Queen Street West	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Portland Street (TO)	West	Adelaide Street West and a point 65 metres south of Richmond Street West	Anytime
Portland Street (TO)	West	Richmond Street West and Queen Street West	Anytime

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Richmond Street West	South	Portland Street and a point 28 metres west	Anytime

D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Portland Street (TO)	West	Richmond Street West and a point 65 metres south	Anytime
Richmond Street West	South	Portland Street and a point 125 metres west	Anytime

E. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Richmond Street West	South	A point 18 metres east of Bathurst Street and Spadina Avenue	2:00 a.m. to 4:00 a.m.

F. By inserting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Richmond Street West	South	A point 18 metres east of Bathurst Street and a point 125 metres west of Portland Street	2:00 a.m. to 4:00 a.m.
Richmond Street West	South	Portland Street and Spadina Avenue	2:00 a.m. to 4:00 a.m.

2. This By-law shall be effective commencing July 17, 2020.
