## CITY OF TORONTO

### BY-LAW 888-2020

#### To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Riverside Drive.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Riverside Drive	East	Mossom Road and Bloor Street West	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

Riverside Drive	East	A point 30 metres north of Riverside Crescent and a point 180 metres further north	Anytime
