BY-LAW 989-2020

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Centre Avenue, Edward Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By deleting from Schedule VI (Commercial Loading Zones) in § 950-1305, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Times and/or Days)
Centre Avenue	West	Between a point 32.7 metres north of Dundas Street West and a point 9.2 metres further north	Anytime
Edward Street	South	Between a point 35 metres east of University Avenue and a point 8.5 metres further east	8:00 a.m. to 6:00 p.m., Mon. to Sat.

- B. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Centre Avenue (TO)	Both	Dundas Street West and Edward Street	Anytime
Edward Street	South	University Avenue and Centre Avenue	Anytime

- C. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Centre Avenue	Both	Dundas Street West and Edward Street	8:00 a.m. to 6:00 p.m., Mon. to Sat.	1 hour

- D. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Centre Avenue (TO)	East	Dundas Street West and a point 18 metres further north	Anytime

- E. By inserting in Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(In Column 1 Intersection)	(In Column 2 Stop Street or Highway)
Edward Street and Centre Avenue	Edward Street
