**CITY OF TORONTO**

**BY-LAW 996-2020**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting the renaming of a portion of Russell Street, between Spadina Crescent and St. George Street, as Ursula Franklin Street.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Russell Street	South	Huron Street (west leg) and St. George Street	Anytime
Russell Street	South	Huron Street and St. George Street	Anytime
