BY-LAW 90-2021

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Bin-Scarth Road, Glen Road, Roxborough Drive.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By deleting from Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(From Column 1 Intersection)	(From Column 2 Stop Street or Highway)
Glen Road and Bin-Scarth Road	Glen Road
Glen Road and Roxborough Drive	Glen Road
Roxborough Drive and Glen Road	Roxborough Drive

- B. By inserting to Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(From Column 1 Intersection)	(From Column 2 Stop Street or Highway)
Glen Road and Roxborough Drive (south intersection)	Glen Road
Roxborough Drive (south intersection) and Glen Road	Roxborough Drive (south intersection)

- C. By deleting from Schedule XXVI (Through Highways) in § 950-1325 the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)
Glen Road	The north side of Bin-Scarth Road and the south side of Roxborough Drive

(In Column 1 Highway)	(In Column 2 Between)	
Glen Road	The north side of South Drive and the south side of Bin-Scarath Road	

D. By inserting to Schedule XXVI (Through Highways) in § 950-1325 the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	
Glen Road	The north side of South Drive and the south side of Roxborough Drive (south intersection)	

E. By deleting from Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Speed Limit (km/h))
Glen Road	Elm Avenue and Summerhill Avenue	40

F. By inserting in Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Speed Limit (km/h))
Glen Road	Elm Avenue and Summerhill Avenue	30
