BY-LAW 91-2021

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting College Street, Lumbervale Avenue, St. Helen's Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
College Street (north branch)	South	St. Helen's Avenue and a point approximately 34 metres east	Anytime
Lumbervale Avenue	North	St. Helen's Avenue and Lansdowne Avenue	Each Thu., Apr. 1 to Nov. 30
Lumbervale Avenue	South	St. Helen's Avenue and Lansdowne Avenue	Anytime, except each Thu., Apr. 1 to Nov. 30
St. Helen's Avenue	East	College Street and Lumbervale Avenue	Anytime, except each Thu., Apr. 1 to Nov. 30
St. Helen's Avenue	West	College Street and Lumbervale Avenue	Each Thu., Apr. 1 to Nov. 30

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
College Street (north branch)	North	St. Helen's Avenue and College Street	Anytime

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Times and/or Days)	(From Column 5 Maximum Period Permitted)
College Street (north branch)	North	College Street and St. Helen's Avenue	Anytime	1 hour

D. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times and/or Days)	(In Column 5 Maximum Period Permitted)
College Street (north branch)	South	College Street and St. Helen's Avenue	Anytime	1 hour
