## CITY OF TORONTO

### BY-LAW 99-2021

#### To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Dewhurst Boulevard and Strathmore Boulevard.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Dewhurst Boulevard	East	Danforth Avenue and Fielding Avenue	Anytime
Strathmore Boulevard	North	Dewhurst Boulevard and Greenwood Avenue	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Dewhurst Boulevard	East	A point 20 metres north of Strathmore Boulevard and Fielding Avenue	Anytime
Dewhurst Boulevard	East	Danforth Avenue and a point 33 metres further north	Anytime
Strathmore Boulevard	North	A point 45 metres west of Donlands Avenue and Greenwood Avenue	Anytime

C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Dewhurst Boulevard	East	A point 33 metres north of Danforth Avenue and a point 20 metres north of Strathmore Avenue	Anytime
Strathmore Boulevard	North	Dewhurst Boulevard and a point 45 metres west of Donlands Avenue	Anytime
Strathmore Boulevard	South	Dewhurst Boulevard and a point 52 metres west of Donlands Avenue	Anytime

D. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Times and/or Days)	(From Column 5 Maximum Period Permitted)
Strathmore Boulevard	South	Dewhurst Boulevard and Donlands Avenue	10:00 a.m. to 6:00 p.m.	1 hour

E. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times and/or Days)	(In Column 5 Maximum Period Permitted)
Strathmore Boulevard	South	A point 52 metres west of Donlands Avenue and Donlands Avenue	10:00 a.m. to 6:00 p.m.	1 hour

F. By inserting in Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Time and/or Days)	(In Column 4 Direction)
Strathmore Boulevard	A point 12 metres north Strathmore Boulevard and a point 40 metres north of Danforth Avenue	Anytime	Southbound

G. By inserting in Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(In Column 1 Intersection)	(In Column 2 Stop Street or Highway)
Dewhurst Boulevard and Strathmore Boulevard	Dewhurst Boulevard
