

CITY OF TORONTO

BY-LAW 102-2021

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Brunel Court, Church Street, Gould Street, Jordon Street and Mutual Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Gould Street	North	A point 18 metres east of a point opposite the east limit of Dalhousie Street and a point 12 metres further east	Anytime
Jordan Street	East	King Street West and a point 17.5 metres south	Anytime

B. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Brunel Court	East	A point 33 metres south of Fort York Boulevard and a point 11 metres further south	7:00 a.m. to 4:00 p.m., Monday to Friday

C. By deleting from Schedule XLIII (Car-Share Vehicle Parking Areas) in § 950-1342, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Number of Spaces)	(From Column 5 Car-Share Organization/Company)
Brunel Court	East	A point 33 metres south of Forth York Boulevard and a point 11 metres further south	2	Zipcare

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Number of Spaces)	(From Column 5 Car-Share Organization/Company)
Church Street	West	A point 30.5 metres south of The Esplanade and a point 11 metres further south	Up to 2	Enterprise CarShare
Gould Street	North	A point 18 metres east of the east curb of Dallhousie Street and a point 12 metres further east	Up to 2	Enterprise CarShare
Jordan Street	East	A point 12 metres south of King Street West and a point 11 metres further south	Up to 2	Enterprise CarShare
Mutual Street	East	A point 20 metres south of Dundas Street East and a point 11.5 metres further south	2	Enterprise

D. By inserting in Schedule XLIII (Car-Share Vehicle Parking Areas) in § 950-1342, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Number of Spaces)	(In Column 5 Car-Share Organization/Company)
Jordan Street	East	A point 17.5 metres south of King Street West and a point 5.5 metres further south	1	Enterprise CarShare
