BY-LAW 115-2021

To authorize the naming of a public lane in a block bounded by Dewhurst Boulevard, Strathmore Boulevard, Donlands Avenue and Danforth Avenue, as Andy Masellis Lane.

Whereas pursuant to Section 27-18.4E(4) of City of Toronto Municipal Code Chapter 27, Council Procedures, Toronto and East York Community Council has the authority to pass a by-law naming the public lane;

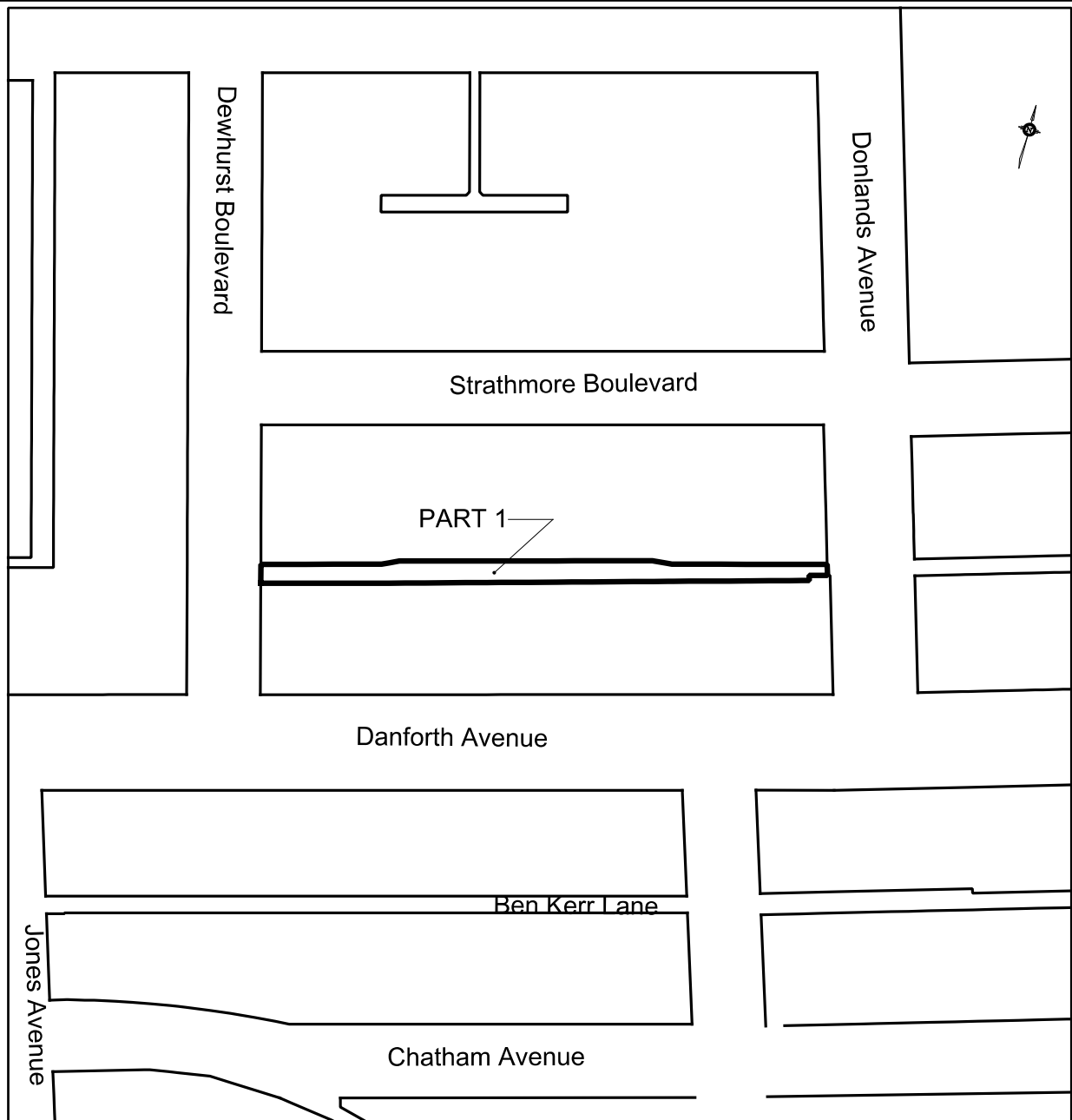
