CITY OF TORONTO

BY-LAW 125-2021

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Dreamers Way, Nicholas Avenue, Oak Street, Sumach Street, Tubman Avenue and Wyatt Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

| (In Column 1 Highway) | (In Column 2 Side) | (In Column 3 Between) | (In Column 4 Prohibited Times and/or Days) |
|-----------------------------|--------------------------|---------------------------------------|---|
| Dreamers Way | East | Oak Street and Gerrard Street East | Anytime |
| Nicholas Avenue | East | Shuter Street and Wyatt Avenue | Anytime |
| Oak Street | North | River Street and Parliament Street | Anytime |
| Tubman Avenue | East | Wyatt Avenue and Oak Street | Anytime |
| Wyatt Avenue | North | River Street and Sumach Street | Anytime |

- B. By inserting in Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

| (In Column 1 Highway) | (In Column 2 Between) | (In Column 4 Time and/or Days) | (In Column 5 Direction) |
|-----------------------------|------------------------------------|--------------------------------------|-------------------------------|
| Dreamers Way | Oak Street and Gerrard Street East | Anytime | Southbound |
| Nicholas Avenue | Shuter Street and Wyatt Avenue | Anytime | Northbound |
| Tubman Avenue | Wyatt Avenue and Oak Street | Anytime | Southbound |
| Wyatt Avenue | River Street and Sumach Street | Anytime | Westbound |

C. By inserting in Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

D. By inserting in Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:
