## CITY OF TORONTO

### BY-LAW 318-2021

#### **To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Strathmore Boulevard and Dewhurst Boulevard, to amend a technical error.**

Whereas Toronto and East York Community Council on February 24, 2021 adopted Item TE23.62, wherein recommendation 5 to the report (February 5, 2021) from the Acting Director, Traffic Management, Transportation Services, recommended designating Dewhurst Boulevard, between a point 12 metres north of Strathmore Boulevard and a point 40 metres north of Danforth Avenue, as one-way southbound; and

Whereas By-law 99-2021, being a by-law "To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Dewhurst Boulevard and Strathmore Boulevard", enacted by Toronto and East York Community Council on February 24, 2021 inadvertently inserted the one-way southbound designation on Strathmore Boulevard, between a point 12 metres north Strathmore Boulevard and a point 40 metres north of Danforth Avenue; and

Whereas pursuant to Section 169-5.2B of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to make technical amendments to the Municipal Code and other by-laws to correct technical errors, to update the by-laws to refer to the current statute, City official title, administrative unit and Municipal Code provision and to repeal by-laws of the former municipalities that have been superseded by provisions in the Municipal Code or as a result of an administrative reorganization;

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
  - A. By deleting from Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Time and/or Days)	(From Column 4 Direction)
Strathmore Boulevard	A point 12 metres north Strathmore Boulevard and a point 40 metres north of Danforth Avenue	Anytime	Southbound

B. By inserting in Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Time and/or Days)	(In Column 4 Direction)
Dewhurst Boulevard	A point 12 metres north of Strathmore Boulevard and a point 40 metres north of Danforth Avenue	Anytime	Southbound
