CITY OF TORONTO

BY-LAW 319-2021

To amend City of Toronto Municipal Code Chapter 925, Permit Parking, respecting Inwood Avenue, to amend a technical error.

Whereas City Council at its meeting of September 27, 2006 enacted By-law 1067-2006, being a by-law "To amend City of Toronto Municipal Code Chapter 925, Permit Parking, to provide for a Harmonized Residential On-Street Permit Parking By-law" and inserted into Schedule A an entry for "Inwood Avenue, Even, From Milverton Boulevard to a point approximately 34.3 metres north, All times, except no parking during the months of Jan., Feb., Mar., Apr., June, Aug., Oct. and Dec., 12:01 a.m. to 7:00 a.m."; and

Whereas By-law 8-2021, being a by-law "To amend City of Toronto Municipal Code Chapter 925, Permit Parking, respecting Donlands Avenue, Frankdale Avenue, Inwood Avenue, Linsmore Crescent, Marlow Avenue, Monarch Park Avenue, Springdale Boulevard and Wiley Avenue (Ward 14)" enacted by Toronto and East York Community Council on January 12, 2021 deleted an entry for "Inwood Avenue, Even, From Milverton Boulevard to a point approximately 34.3 metres north, All times, except no parking during the months of Jan., Feb., Mar., Apr., June., Aug., Oct. and Dec., 12:01 a.m. to 7:00 a.m." although the entry was inadvertently captured in Schedule A to Code Chapter 925 as "Inwood Avenue" and as such should have been deleted as "Inwood Avenue"; and

Whereas Section 169-5.2B of City of Toronto Municipal Code Chapter 169, Officials, City, authorizes the City Solicitor, in consultation with the City Clerk, to submit bills directly to make technical amendments to the Municipal Code and other by-laws to correct technical errors;

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 925, Permit Parking, is amended as follows:
 - A. By deleting from Schedule A (Permit Parking), the following in alphabetical order by street name:

(From Column 1 Street)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Period)	(From Column 5 Time)
Inwood Avenue	Even	From Milverton Boulevard to a point approximately 34.3 metres north	All times, except no parking during the months of Jan., Feb., Mar., Apr., June, Aug., Oct. and Dec.	12:01 a.m. to 7:00 a.m.
