BY-LAW 437-2021

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Dreamers Way, Nicholas Avenue, Oak Street, Sumach Street, Tubman Avenue, and Wyatt Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:
