BY-LAW 473-2021

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Ford Street, Osler Street, St. Clair Avenue West.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Osler Street	West	St. Clair Avenue West and Cariboo Avenue	All times

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Osler Street	West	A point 52 metres south of St. Clair Avenue West and Cariboo Avenue	All times

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
St. Clair Avenue West	South	A point 15 metres east of Ford Street and Osler Street	7:00 a.m. to 9:00 p.m., Mon. to Fri.

D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Ford Street	East	St. Clair Avenue West and a point 60 metres south	All times
Osler Street	West	St. Clair Avenue West and a point 52 metres south	All times
St. Clair Avenue West	South	Ford Street and Osler Street	All times

E. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Ford Street	East	St. Clair Avenue West and Connolly Street	8:00 a.m. to 6:00 p.m., Mon. to Sat.	1 hour

F. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Ford Street	East	Connolly and a point 60 metres south of St. Clair Avenue West	8:00 a.m. to 6:00 p.m., Mon. to Sat.	1 hour
