BY-LAW 529-2021

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting
George Street.**

The Etobicoke York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
George Street (YK)	East	A point 202 metres north of King Street and Church Street	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
George Street	East	Fern Avenue and Church Street	Anytime
George Street	East	Fern Avenue and a point 83 metres south	9:00 a.m. to 2:30 p.m. and 3:30 p.m. of one day to 8:00 a.m. of the next following day

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
George Street (YK)	West	A point 31 metres north of King Street and a point 43 metres further north	Anytime

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
George Street (YK)	East	King Street and point 202 metres north	Anytime

D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
George Street	Both	King Street and a point 160 metres north	Anytime

E. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
George Street	East	Fern Avenue and a point 83 metres south	8:00 a.m. to 9:00 a.m. and 2:30 p.m. to 3:30 p.m., Mon. to Fri.	10 mins.
