BY-LAW 634-2021

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting the designation of a Community Safety Zone on Isabella Street and on Islington Avenue.

Whereas City Council on July 16, 17 and 18, 2019 adopted, as amended, Item IE6.8, wherein Attachment 1 to the report (June 13, 2019) from the General Manager, Transportation Services and the General Manager, Solid Waste Management Services, recommended the designation of a Community Safety Zone on Isabella Street and Islington Avenue; and

Whereas City Council on May 28, 2020 enacted By-law 407-2020, being a by-law "To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting the designation of Community Safety Zones at secondary school locations on various highways as part of Vision Zero 2.0 Road Safety Plan Update" and inadvertently inserted into Schedule XXXIII (Community Safety Zones) only one entry, that being for Isabella Street, but inadvertently using the side, location, prohibited hours and/or days as well as prohibited months information for what was authorized for the Islington Avenue entry; and

Whereas pursuant to Section 169-5.2B of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors, to update the by-laws to refer to the current statute, City official title, administrative unit and Municipal Code provision and to repeal by-laws of the former municipalities that have been superseded by provisions in the Municipal Code or as a result of an administrative reorganization;

The Council of the City of Toronto enacts:

- A. By deleting from Schedule XXXIII (Community Safety Zones) in § 950-1332 the following in alphabetical order by street name:
