CITY OF TORONTO

BY-LAW 723-2021

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Dewbourne Avenue, Old Forest Hill Road and Vesta Drive.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Dewbourne Avenue	South	Glenayr Road and Old Forest Hill Road	2:00 a.m. to 7:00 a.m., Mon. to Fri., except public holidays
Old Forest Hill Road	West	A point 41.1 metres south of Eglinton Avenue West and Vesta Drive	8:00 a.m. to 6:00 p.m., Monday to Saturday

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Dewbourne Avenue	South	Glenayr Road and a point 30 metres west of Old Forest Hill Road	2:00 a.m. to 7:00 a.m., Mon. to Fri., except public holidays
Dewbourne Avenue	South	Old Forest Hill Road and a point 30 metres further west	Anytime
Old Forest Hill Road	West	A point 41.1 metres south of Eglinton Avenue West and a point 15 metres north of Vesta Drive (north intersection)	8:00 a.m. to 6:00 p.m., Mon. to Sat.
Vesta Drive	East	Old Forest Hill Road and a point 20 metres further south	Anytime

C. By deleting from Schedule XXVII (Compulsory Stops) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Intersection)	(From Column 2 Stop Street or Highway)
Dewbourne Avenue and Vesta Drive	Dewbourne Avenue
Old Forest Hill Road and Vesta Drive	Old Forest Hill Road
Vesta Drive and Dewbourne Avenue	Vesta Drive
Vesta Drive and Old Forest Hill Road	Vesta Drive

D. By inserting in Schedule XXVII (Compulsory Stops) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Intersection)	(In Column 2 Stop Street or Highway)
Dewbourne Avenue and Old Forest Hill Road	Dewbourne Avenue
Old Forest Hill Road and Dewbourne Avenue	Old Forest Hill Road
Vesta Drive and Old Forest Hill Road	Vesta Drive (north and south intersection)

E. By inserting in Schedule XXX (Heavy Vehicles Prohibited) in § 950-1329, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Prohibited Times and/or Days)
Vesta Drive	Eglinton Avenue West and Old Forest Hill Road	Anytime
