BY-LAW 864-2021

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Cowan Avenue, Craven Road, Eversfield Road, Fulton Avenue, Glenholme Avenue, Mapleview Avenue, Riverdale Avenue, Uxbridge Avenue, Vernon Street and Windermere Avenue.

The Toronto and East York Community Council enacts:

- 1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
- A. By deleting from Schedule II (Designated On-Street parking for Permit Holders), the following in alphabetical order by street name:

| Fulton Avenue | North | A point 99 metres east of Jackman Avenue and a point 5.5 metres further east | Anytime |

| Vernon Street | South | A point 95.5 metres east of Runnymede Road and a point 5.5 metres further east | Anytime |

B. By inserting in Schedule II (Designated On-Street parking for Permit Holders), the following in alphabetical order by street name:

| Glenholme Avenue | West | A point 78.3 metres south of Hanson Road and a point 5.5 metres further south | Anytime from Dec. 1 to Mar. 31 of the following year, inclusive and from the 16th day of each month to the last day of each month, Apr. 1 to Nov. 30, inclusive |
| Mapleview Avenue | West | A point 45.4 metres north of MacGregor Avenue and a point 5.5 metres further north | Anytime |
| Riverdale Avenue | South | A point 81 metres east of Broadview Avenue and a point 5.5 metres further east | Anytime |
| Windermere Avenue | East | A point 104.5 metres south of St John's Road and a point 5.5 metres further south | Anytime |
