CITY OF TORONTO

BY-LAW 880-2021

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting the designation of Ward 23 (Area 5) Boundary Area designated area and 30 kilometres per hour for public lanes and local roads within the designated area.

Whereas Scarborough Community Council on May 18, 2021 adopted Item SC24.15, wherein Attachment 1 to the report (April 29, 2021) from the Director, Project Design and Management, Transportation Services, recommended the designation of Ward 23 (Area 5) as a designated area with a speed limit of 30 km/h, with the exception of specified excluded highways or bridges, and therein inadvertently incorrectly referenced "Staines Road" in some instances as "Staines Drive" or as "Stains Road" and, in one instance, incorrectly referred to "Tait Court" as "Tait Cout"; and

Whereas Scarborough Community Council on May 18, 2021 enacted By-law 415-2021, being a by-law "To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, with respect to the designation of Ward 21 (Area 1, Area 2, Area 3, Area 4, Area 5, Area 6, Area 7, Area 8, Area 9, Area 10, Area 11, Area 12, Area 13, Area 15, Area 16) and Ward 23 (Area 1, Area 2, Area 3, Area 4, Area 5, Area 6, Area 7, Area 8, Area 9, Area 10, Area 11, Area 12, Area 13, Area 14, Area 15, Area 16) Boundary Area designated area and 30 kilometres per hour for public lanes and local roads within the designated area", which by-law also inadvertently in some instances incorrectly referenced "Staines Road" as Staines "Drive" or inserted the incorrect spelling of Staines Road as "Stains" and, further, in one instance incorrectly referred to "Tait Court" as "Tait Cout"; and

Whereas pursuant to Section 169-5.2B of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors, to update the by-laws to refer to the current statute, City official title, administrative unit and Municipal Code provision and to repeal by-laws of the former municipalities that have been superseded by provisions in the Municipal Code or as a result of an administrative reorganization;

The Scarborough Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

- A. By deleting from Schedule XLV (Part 1): Designated Areas – Reduced Speed Areas in § 950-1344, the following in alphabetical order by designated area name:
