BY-LAW 993-2021

To amend City of Toronto Municipal Code Chapter 910, Parking Machines and Meters, respecting Carling Avenue, Dorval Road, Margueretta Street, Parkview Gardens, Roxton Road and Rusholme Road.

The Toronto and East York Community Council enacts:

- Chapter 910, Parking Machines and Meters, is further amended by adding the following in alphabetical order to Schedule I, Parking Machines:
