## CITY OF TORONTO

### BY-LAW 994-2021

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Carling Avenue, Dorval Road, Margueretta Street, Pauline Avenue, Parkview Gardens, Roxton Road and St. Clarens Avenue.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
  - A. By inserting in Schedule VI (Commercial Loading Zones) in § 950-1305, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
Carling Avenue	East	Bloor Street West and 26 metres further north	Anytime
Margueretta Street	East	A point 15m north of Bloor Street West and a point 11 metres further north	Anytime
Pauline Avenue	East	15 metres north of Bloor Street West and the laneway	Anytime
St. Clarens Avenue	East	A point 17 metres north of Bloor Street West and a point 16 metres further north	Anytime

St. Clarens Avenue	West	Bloor Street West and a point 76.2 metres north	Anytime
St. Clarens Avenue	East	The first lane north of Bloor Street West and a point 43.2 metres further north	Anytime

D. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

Carling Avenue	East	Bloor Street West and Leeds Street	Anytime	1 hour
Dorval Road	West	Bloor Street West and Edna Avenue	8:00 a.m. to 6:00 p.m.	1 hour
Parkview Gardens	East	Bloor Street West and a point 45.7 metres north	8:00 a.m. to 6:00 p.m., Mon. to Fri.	1 hour

E. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

Carling Avenue	East	Irene Avenue and Leeds Street	Anytime	1 hour
Dorval Road	West	Laneway north of Bloor Street West, east of Indian Road and Edna Avenue	8:00 a.m. to 6:00 p.m.	1 hour
