

CITY OF TORONTO

BY-LAW 999-2021

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Arnold Street, Berkeley Street, Cole Street, Dalhousie Street, Dundas Street East, George Street, Milan Street, Mutual Street, Pashler Avenue, Peaceful Way, Poulett Street, Regent Park Boulevard, Regent Street, Sackville Street, St. Bartholomew Street, St. David Street, Seaton Street, Sumach Street, Sutton Street and Tubman Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
