

CITY OF TORONTO

BY-LAW 1006-2021

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Bond Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Bond Street	East	A point 17.5 metres north of Shuter Street and a point 40.9 metres further north	8:30 a.m. to 11:30 a.m., 1:30 p.m. to 3:30 p.m., 5:00 p.m. of one day to 7:30 a.m. of the next following day, Mon.to Fri.; Anytime, Sat. and Sun.
Bond Street	East	A point 83 metres north of Shuter Street and a point 29.8 metres further north	8:30 a.m. to 11:30 a.m., 1:30 p.m. to 3:30 p.m., 5:00 p.m. of one day to 7:30 a.m. of the next following day, Mon.to Fri.; Anytime, Sat. and Sun.

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

C. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

Bond Street	East	A point 17.5 metres north of Shuter Street and a point 40.9 metres further north	7:30 a.m. to 8:30 a.m., 11:30 a.m. to 1:30 p.m., 3:30 p.m. to 5:00 p.m. Mon. to Fri.	10 mins.
Bond Street	East	A point 83 metres north of Shuter Street and a point 29.8 metres further north	7:30 a.m. to 8:30 a.m., 11:30 a.m. to 1:30 p.m., 3:30 p.m. to 5:00 p.m., Mon. to Fri.	10 mins.
