BY-LAW 1012-2021

To amend City of Toronto Municipal Code Chapter 925, Permit Parking, respecting Aitken Place, Berkeley Street, Douville Court, Hahn Place, Longboat Avenue, Portneuf Court, Princess Street and Scadding Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 925, Permit Parking, is amended as follows:
 - A. By inserting in Schedule A (Permit Parking), the following in alphabetical order by street name:

Berkeley Street	Even	From The Esplanade to Front Street East	All times, except no parking 8:00 a.m. to 5:00 p.m. Mon. to Fri., from Front Street East to a point 44.2 metres further south	12:00 a.m. to 11:59 p.m., 7 days a week for the duration of the Distillery Winter Village from November 24, 2021 to December 31, 2021
Douville Court	Even	From Longboat Avenue to the north end of Douville Court	All times	12:00 a.m. to 11:59 p.m., 7 days a week for the duration of the Distillery Winter Village from November 24, 2021 to December 31, 2021

B. By inserting a new § 925-9.2 as follows:

"§ 925-9.2. Conflict during 2021 Distillery Winter Village.

From 12:00 a.m. to 11:59 p.m., 7 days a week, for the duration of the Distillery Winter Village from November 24, 2021 to December 31, 2021 inclusive, where any regulation contained in Section 1A of By-law 1012-2021 conflicts with any other regulation in Schedule A to this chapter, the regulation in Section 1A of By-law 1012-2021 shall prevail."

Enacted and passed on November 24, 2021.
