BY-LAW 64-2022

To amend City of Toronto Municipal Code Chapter 925, Permit Parking, respecting Howard Park Avenue, South Kingsway and Varsity Road

Whereas Toronto and East York Community Council on September 16, 2020 adopted as amended Item TE18.64, wherein Attachment A to the report (August 20, 2020) from the Manager, Permits and Enforcement, Parking and Administration, included entries for adding permit parking on various streets in wards 4, 9 and 14; and

Whereas By-law 85-2021, being a by-law "To amend City of Toronto Municipal Code Chapter 925, Permit Parking, respecting the introduction of overnight permit parking on South Kingsway" and By-law 564-2021, being a by-law "To amend City of Toronto Municipal Code Chapter 925, Permit Parking, respecting the introduction of overnight permit parking on Althea Road, Bradley Avenue, Bralorne Crescent, Brummell Avenue, Crosby Avenue, Doran Avenue, Gooch Avenue, Gooch Court, Grand Park Court, Humber Hill Avenue, Humbercrest Boulevard, Irmac Court, Juliana Court, Kentucky Avenue, Langmuir Gardens, Magwood Court, Old Dundas Street, Pasadena Gardens, Sidford Court, Skylark Road, St. John's Road, St. Mark's Road, Sun Valley Drive, Thornhill Avenue, Van Stassen Boulevard, Varsity Road within Permit Parking Area 1K (Ward 9)" inadvertently included additional entries for South Kingsway and Varsity Road without the designated Community Council authority; and

Whereas pursuant to Section 169-5.2B of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors, to update the by-laws to refer to the current statute, City official title, administrative unit and Municipal Code provision and to repeal by-laws of the former municipalities that have been superseded by provisions in the Municipal Code or as a result of an administrative reorganization; and

Whereas City Council on February 2 and 3, 2022 adopted as amended Item TE30.26, authorizing the insertion of entries into Schedule A to Chapter 925, Permit Parking, for Howard Park Avenue, South Kingsway, and Varsity Road;

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 925, Permit Parking, is amended as follows:

A. By deleting from Schedule A (Permit Parking), the following in alphabetical order by street name:
