

CITY OF TORONTO

BY-LAW 77-2022

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Bloor Street East, Coxwell Avenue, Fenn Avenue, Hillcrest Avenue, Huntingwood Drive, Old Sheppard Avenue, Overlea Boulevard, Plains Road, Rogers Road and Wedge Court.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XXXIII (Community Safety Zones) in § 950-1332 the following in alphabetical order by street name:
