

CITY OF TORONTO

BY-LAW 107-2022

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Aberdeen Avenue, Ardagh Street, Boler Street, Boston Avenue, Carlton Street, Donmore Avenue, Indian Grove, Harvie Avenue, Highfield Road, Lippincott Street, Sammon Avenue, Warren Crescent, Waverly Road, Woodfield Road.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:

A. By deleting from Schedule II (Designated On-Street parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Harvie Avenue	East	A point 9 metres north of Hope Street and a point 5.5 metres further north	Anytime
Harvie Avenue	West	A point 7 metres north of Hope Street and a point 5.5 metres further north of it	Anytime
Indian Grove	West	A point 192.6 metres south of Humberside Avenue and a point 5.5 metres further south	Anytime
Sammon Avenue	North	A point 32.2 metres west of Inwood Avenue and a point 5.5 metres further west	Anytime
Warren Crescent	South	A point approximately 92 metres west of Varsity Road and a point 5.5 metres further west	Anytime

B. By inserting in Schedule II (Designated On-Street parking for Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Aberdeen Avenue	North	A point 34 metres east of Ontario Street and a point 5.5 metres further east	Anytime
Ardagh Street	North	A point 77 metres west of Runnymede Road and a point 5.5 metres further west	Anytime

Boler Street	West	A point 37 metres north of Maria Street and a point 5.5 metres further north	Anytime
Boston Avenue,	East	A point 71 metres north of Queen Street East and a point 5.5 metres further north	Anytime
Carlton Street	South	A point 60 metres east of Parliament Street and a point 5.5 metres further east	Anytime
Donmore Avenue	West	A between a point 43 metres south of Memorial Park Avenue and a point 5.5 metres further south	Anytime
Highfield Road	East	A point 114 metres north of Gerrard Street East and a point 5.5 metres further north	Anytime
Highfield Road	West	A point 114 metres north of Gerrard Street East and a point 5.5 metres further north	Anytime
Lippincott Street	East	A point 13.5 metres north of Vankoughnet Street and a point 5.5 metres further north	Anytime
Waverley Road	West	A point 166 metres south of Kingston Road and a point 5.5 metres further south	Anytime
Woodfield Road	West	A point 43 metres south of Fairford Avenue and a point 5.5 metres further south	Anytime
