

CITY OF TORONTO

BY-LAW 271-2022

To amend City of Toronto Municipal Code Chapter 886, Footpaths, Pedestrian Ways, Bicycle Paths, Bicycle Lanes and Cycle Tracks, respecting Bartlett Avenue, Bartlett Avenue North, Bloor Street West, Havelock Street, Gladstone Avenue and Lindsey Avenue.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 886, Footpaths, Pedestrian Ways, Bicycle Paths, Bicycle Lanes, and Cycle Tracks, is amended as follows:
 - A. By inserting in Schedule D (Designated Lanes for Bicycles) the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Lanes)	(In Column 4 Times or Days)
Bartlett Avenue North	Davenport Road and a point 46 metres north of Geary Avenue	Westerly Southbound	Anytime
Bartlett Avenue North	Geary Avenue and a point 36 metres south	Westerly Southbound adjacent to parking and Easterly Northbound adjacent to parking	Anytime
Bartlett Avenue	Dupont Street and Hallam Street	Westerly Southbound	Anytime
Bartlett Avenue	Hallam Street and Shanly Street	Easterly Northbound	Anytime
Bartlett Avenue	Shanly Street and a point 84 metres north of Bloor Street West	Westerly Southbound	Anytime
Gladstone Avenue	Sylvan Avenue and a point 11 metres south	Westerly Southbound	Anytime
Gladstone Avenue	Lindsey Avenue and a point 9 metres south	Westerly Southbound	Anytime

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Lanes)	(In Column 4 Times or Days)
Gladstone Avenue	College Street and a point 58 metres north	Westerly Southbound	Anytime
Havelock Street	Bloor Street West and a point 15 metres south	Easterly Northbound	Anytime
Havelock Street	Bloor Street West and Dewson Street	Westerly Southbound	Anytime
Lindsey Avenue	Havelock Street and Gladstone Avenue	Northerly Westbound	Anytime

B. By inserting in Schedule E (Cycle Tracks) the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Lanes)	(In Column 4 Times or Days)
Bloor Street West	Bartlett Avenue and Havelock Street	Northerly Eastbound lane adjacent to Northerly Westbound cycle track	Anytime
Havelock Street	Sylvan Avenue and Dewson Street	Westerly Southbound and Easterly Northbound	Anytime
