BY-LAW 384-2022

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Melita Crescent.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Melita Crescent	East, north and west	Lambertlodge Avenue (west intersection) and Lambertlodge Avenue (east intersection)	Each Thu., Apr. 1 to Nov. 30, inclusive
Melita Crescent	West, south and east	Lambertlodge Avenue (west intersection) and Lambertlodge Avenue (east intersection)	Anytime, except Thu., Apr. 1 to Nov. 30, inclusive

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Melita Crescent	East	Lambertlodge Avenue (west intersection) and Wychcrest Avenue (west intersection)	Each Thu., Apr. 1 to Nov. 30, inclusive
Melita Crescent	East	Wychcrest Avenue (west intersection) and a point 43 metres south	7:01 a.m. to 12 midnight, from the 16th day to the last day of each month, Apr. 1 to Nov. 30, inclusive

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Melita Crescent	North and west	A point 61 metres south and east of Wychcrest Avenue (west intersection) and Lambertlodge Avenue (east intersection)	Each Thu., Apr. 1 to Nov. 30, inclusive
Melita Crescent	West, south and east	A point 55 metres south of Wychcrest Avenue (west intersection) and Lambertlodge Avenue (east intersection)	Anytime, except Thu., Apr. 1 to Nov. 30, inclusive
Melita Crescent	West	Lambertlodge Avenue (west intersection) and Wychcrest Avenue (west intersection)	Anytime, except Thu., Apr. 1 to Nov. 30, inclusive
Melita Crescent	West	Wychcrest Avenue (west intersection) and a point 44 metres south	7:01 a.m. to 12 midnight, from the 1st day to the 15th day of each month, Apr. 1 to Nov. 30, inclusive
Melita Crescent	West	Wychcrest Avenue (west intersection) and a point 44 metres south	Anytime, from Dec. 1 of one year to Mar. 31, of the next following year, inclusive
