

**CITY OF TORONTO**

**BY-LAW 395-2022**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting  
Freeman Street and Phenix Drive**

The Scarborough Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Freeman Street	South	A point 25 metres east of Eastwood Avenue (westerly leg) and Phenix Drive	7:00 a.m. to 9:00 a.m., Mon. to Fri.

B. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Freeman Street	South	A point 25 metres east of Eastwood Avenue (westerly leg) and a point 31 metres east from Phenix Drive	7:00 a.m. to 9:00 a.m., Mon. to Fri.

C. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Freeman Street	South	Birchcliff Avenue and Phenix Drive	8:00 a.m. to 4:00 p.m., Mon. to Fri.	30 mins.

D. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Freeman Street	South	Birchcliff Avenue and a point 31 metres east of Phenix Drive	8:00 a.m. to 4:00 p.m., Mon. to Fri.	30 mins.

E. By deleting from Schedule XXVI (Through Highways) in § 950-1325, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)
Freeman Street	The east side of Eastwood Avenue and Birchcliff Avenue

F. By inserting in Schedule XXVI (Through Highways) in § 950-1325, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)
Freeman Street	The east side of Eastwood Avenue and the west side of Phenix Drive
Freeman Street	The east side of Phenix Drive and Birchcliff Avenue

G. By inserting in Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(In Column 1 Intersection)	(In Column 2 Stop Street or Highway)
Freeman Street and Phenix Drive	Freeman Street
Phenix Drive and Freeman Street	Phenix Drive
